## **Opus Prodox AB wins an important new order from BMW**

### ***– Opus to deliver a new, electronic driver log system for the company in the DACH-region***

Opus Prodox AB has won its first order for the company's new top product, TripLogPRO, an electronic driver log system that also contains GPS and a map software. A new version of TripLogPRO was launched at the CEBIT trade show earlier in the year and BMW is now the first customer. The system has been specially adapted for the DACH region, i.e. Germany, Austria and Switzerland. The order is worth SEK 1.5 million.

Opus has collaborated with BMW and delivered electronic driver log systems since 2006. The new version of TripLogPRO has been produced according to BMW's specific requirements and the collaboration has thus been further extended by the new order.

"Sales of the driver log systems during 2007 did not meet our true expectations but our development work has considerably improved its business potentials," says Magnus Greko, MD for Opus. "The new product has been tailor-made for Germany, Austria and Switzerland, and is also simpler to connect into a computer; an explicit customer requirement."

The potentials for the new product are good. This is particularly due to a new regulation that was introduced for the self-employed in Germany during 2007. The regulation means that the split between commercial and private driving in company cars must be reported to the tax authorities.

"We believe that this will create a large market for electronic driver log systems in Germany, however this will depend on the authorities' requirements being followed up," says Magnus Greko. "Sales have increased during 2008 and hopefully the order from BMW is only the first of many similar ones. This is not least because the new version of TripLogPRO is suitable for many different markets."
