## J&B signs subcontractor agreement with YIT regarding equipment service for the Swedish state-owned vehicle inspection company, AB Svensk Bilprovning

**Opus Prodox AB (publ) today announces that its wholly owned subsidiary, J&B Maskinteknik AB, has signed an agreement with YIT Sverige AB regarding calibration and service of all test equipment at Bilprovningen.**

The agreement is a subcontract to the three-year contract signed between YIT and AB Svensk Bilprovning on October 28, 2009 regarding facility management services, and more, for Bilprovningen's properties in Sweden. J&B's responsibilities will include the part of the agreement relating to calibration and service of test equipment for vehicle inspection. The agreement runs until December 31, 2012 with the possibility of three two-year extensions. The contract period is linked to the contract term applicable in respect of the agreement between YIT and Bilprovningen.

The agreement includes periodic maintenance of all equipment and installations. J&B shall in addition to performing supervisory services and maintenance also carry out equipment repairs. The contract value is estimated to approximately SEK 15 million excluding any extensions.

J&B will in connection to this take over six technicians from YIT and related machinery, equipment and vehicles. J&B will as a result gain a nationwide service organization and a strong platform for future growth.

"J&B has been working with YIT since the agreement was signed with Bilprovningen, where we as a subcontractor have provided some of the services that YIT has had to perform for Bilprovningen. It is with great pleasure that we now can conclude that all parties have been very pleased with the past co-operation and that we now formalize a long term co-operation together" says John-Anders Hansson, CEO of J&B.

J&B performs installations, services, repair and accredited calibration of various workshop equipment for workshops and vehicle inspection stations in Sweden. Sales for 2009 amounted to approximately SEK 9.3 million and the company had nine employees at year-end, of which eight service technicians.
